Conifex Announces Closing of Sale of Lignum Forest Products

April 1, 2019, Vancouver, BC - Conifex Timber Inc. ("Conifex") (TSX: CFF) announced today that it has closed its previously announced transaction with certain subsidiaries of Canwel Building Materials Group Ltd. for the sale of Lignum Forest Products LLP. The consideration for the transaction was approximately US\$11.5 million, including approximately US\$10.5 million for working capital. The estimated working capital is subject to customary post-closing adjustments.
